#### 1. CALL TO ORDER at 7:09 PM

2. APPROVAL OF AGENDA Norma moves to accept the agenda, Lynda seconds, motion carries

#### 3. APPROVAL OF MINUTES

- Board meeting May 13, 2013 Haidee moves to approve the minutes of the previous meeting, Lynda seconds, motion carries

- c. Release & Waiver Move forward with the finalized version of the waiver in the new year October meeting will be used to promote this form/version with each of the zones for 2014.
- d. Honorary membership for Linda Noble and Sue Wyllie (Spelay)
  - a. Next Steps in this process will be discussed at the October meeting
- e. Drug Penalty Policy
  - a. Next steps ( ie small committee )- no action
  - b. Drug Testing under way in BC shows Laurie will be asking at R1 re testing policies in other affiliates. Gayle asks for a meeting before Oct. for drug penalty policy. Gordie to arrange a meeting/conference call in late September
  - c. Question re AQHA Reining show in Chilliwack charging drug testing fee. It was confirmed this was actually the AQHA processing fee.
- f. Update on extreme trail events –Due to unavailability of the facility, the Trail Challenge/Trail ride in Hope was cancelled. Laurie reports that SC has contacted Conti's numerous times to arrange a Trail challenge with no response.
- g. Need VI and NBC rep for Awards committee still no volunteers.
- h. AQHA request for information Has been completed
  - a. Ie financial information/ director's /officers/ BCQHA contact info.
- i. BCQHA Novice Amateur Qualifiers reported under correspondence
- j. Directors Responsibility Policy carry over to October meeting

- k. Societies Act update for BCQHA Norma has the paper work and will confirm with Gordie that it was sent off
- 1. BCQHA Points /Awards 2013 2 points keepers have been found and show results are starting to come in from AQHA
- m. Region One Need help to collect more donations for the BCQHA basket and need help with delivering the BCQHA social Friday Aug 16. Laurie will bring some basket items, but can't help with the social as she won't be staying.
- n. AGM venue update Darhl suggests that we may need to move the AGM out of the North due to low number of members and the need to secure a quorum for this meeting. Have a discussion in October regarding the location of the 2014 AGM
- o. Other Items for a raffle have been purchased deferred to the October meeting agenda to plan raffle.

#### 7. NEW BUSINESS

a. BCQHA Website – South Central rep, Laurie wants all directors to see the website contract, wants to know what the timeframe is for updates. SC feels that because they are paying for the website that they should have final say on what content and pictures goes on their web page. SC Directors don't recall seeing the contract. Sometimes updates take months. No specific incidents were given.

Lynne reports SC updates never take longer than one week but sometimes it can be done instantaneously if she happens to be on the computer. Only thing that will stretch that timeframe is if the items sent to upload are too large. Lynne has asked for the pictures from the members of each zone to volunteer an additional component to the zones webpages and also includes non show pictures of members.

Nothing has changed in the website contract that SC Director Cheri saw and approved along with the rest of the BOD. Darhl doesn't recall seeing the website contract. Lynne reminds Darhl Paley that he hasn't yet renewed his 2013 membership. NBC reps Darhl Paley and Doug Baker are not currently members in good standing.

Other directors complimented the work Lynne volunteers on the website

- b. Zone Approval Smithers show bypassed NBCQHA approval and went straight to BCQHA for approval. NBC didn't receive the approval fee that helps to run the NBC zone and award program.
