## **AQHA Region One Scholarship Criteria**

### **Procedure:**

Region One submits their criteria to the AQHA Foundation and it is listed as a scholarship available for Youth.

The AQHA Foundation Committee receives the applications and reviews it to the available scholarships. This means that if a Youth residing in Region One did not get a scholarship under our criteria they may still eligible for another less restrictive scholarship.

## E.g.:

# Region One Quarter Horse Youth Scholarship

\$2,500 four- year scholarship (note below)

Ideal candidates will reside within Alaska, British Columbia, Idaho, Oregon, or Washington. Candidate must have been a member of AQHA or AQHYA as well as one of the following AQHA affiliates for at least one year; Alaska, British Columbia, Idaho, Oregon or Washington. Member must apply during their senior year of high school or while enrolled at an accredited college or university. Recipient must maintain a minimum cumulative 2.5 grade point average. Current or previous AQHF scholarship recipients are not eligible to receive this scholarship. Funding for this scholarship will be applied to a four-year undergraduate degree program of the student's choice.

## **Questions:**

When the funds are available do we want to do two \$2,500 scholarships or one \$5,000 scholarship?

I think we need to keep the residency requirement in place, as well as the minimum one year membership in AQHA and AQHYA. Other opinions?

One year minimum membership in one of the five affiliates.

Member must apply during their senior year of high school or while enrolled at an accredited college or university.

Recipient must maintain a minimum cumulative 2.5 grade point average. Reasonable?

Note: criteria has been addressed for Canadian applicants.

Current or previous AQHF scholarship recipients are not eligible to receive this scholarship. This is standard among AQHF scholarships.

Funding for this scholarship will be applied to a four-year undergraduate degree program of the student's choice. ?? Or.. would you like to also include two-year, vocational schools and or special programs or any variation of?

There are a few questions you may wish to discuss in the criteria but this is fairly standard with most AQHA Foundation Scholarships.

# 2013 BCQHA AWARDS REPORT

I would like to thank Gordie, Lynne and Lynda for their valuable assistance this year in getting the 2013 BCQHA Awards together and distributed to the members.

The BCQHA 2013 Awards booklet was posted on the BCQHA web site in March 2014. Below are the approximate expenditures including taxes that I believe we spent for the 2013 awards.

#### **Items Awarded:**

The option was given to multiple winners to combine their award value for a larger item instead of single items. Two All Around winners requested certificates for Schneider's Saddlery in the USA. The committee chose to award a cheque in Canadian funds instead of a certificate.

Three Reserve All Around awards were combined for a fleece cooler custom embroidered.

All Around items: three styles of jackets chosen, one custom blanket carrier made by Denise Fisher, two Smart Pak hoodies. These items were all embroidered by Denise Fisher, Langley who has been an excellent help with these awards.

The Reserve All Around awards for adult and Volunteers were BCQHA logoed carving sets, the Youth were awarded logoed thermos sets and one tote/fleece.

All winners including Hi Point and Reserve Hi Point all divisions were given certificates.

### **Summary:**

The budget for 2013 Awards was much less than previous years. The award items such as jackets were slightly higher and the taxes always increase the actual costs on all items.

We had discussed recirculating the BCQHA perpetual trophies to the All Around award winners but unfortunately we could not accomplish that task this year.

The plaques for the refurbished trophies will still cost approximately \$12.95 and there was no room in the budget or enough time for the BCQHA 2013 awards.

## **Proposal:**

I propose that the trophies be offered for 2014 to the All Around winners and request that they pay for the plaque. They would still get a logoed item to continue the BCQHA branding along with the trophy to keep. I feel this would be a good option for winners who would really appreciate a heritage BCQHA trophy.
